<p>I, Shari Worthington, on behalf of the Mass Family Institute, obtained from the City of Worcester a Facility Permit for a rally to be held at the Worcester City Hall Plaza on Dec. 16, 2006 from 1:30pm-2:30pm. No other group or individual had a permit for a rally at that location for the same date and time. The rally was to be held for the purpose of urging the legislature to permit a citizens' petition defining marriage as a union of one man and one woman to go before the people for a vote. A few days before the rally, I was assured by the Worcester City Police that any other groups opposing the rally would be kept apart from the permitted rally.</p> <p>The rally took place at the location and on the date and time stated in the permit. Opposing groups appeared at the site of the rally. I understand from the Police Report that the police told these opposing groups to stay back and not obstruct the rally.</p> <p>While the permitted rally was taking place, and there was a speaker at the podium speaking to the audience, a person (later identified to me as Sarah Loy) entered into the space where the rally was taking place. She stood in front of the podium, between the rally participants and the speaker, blocking the view of the audience.</p>
