Join the movement to take back your government!

How can this happen in America? The arrest and jailing of a parent over his objections to the teaching of homosexuality to his son in kindergarten is outrageous beyond belief. And David Parker is still under threat of prosecution by the State of Massachusetts, and continues to be banned from all school property by the town of Lexington. What kind of people would participate in this? What kind of government would do this?

The illegal and unconstitutional same-sex "marriage" ruling was just the beginning. But this is what happens to a free society when ordinary people sit still. Several of our founding fathers warned that "eternal vigilance is the price of liberty. The nation is watching us." This is a defining moment.. It's time for people who cherish freedom to act.

The same-sex "marriage" ruling has emboldened our schools. The assumed official legitimization of homosexuality in Massachusetts has accelerated the coercive indoctrination of our children. David Parker's arrest is just one example of the recent abuses that can be directly linked to that ruling.

This is just a partial list of the horror stories that have happened in the public schools since that ruling.

- Openly lesbian 8th-grade teacher at Brookline High School tells National Public Radio that parents can't stop her from pushing homosexuality: "If somebody wants to challenge me, I'll say, 'Give me a break. It's legal now.'"

- Gay and transgender awareness days at high schools, where children are told to ignore their parents' values on traditional marriage and learn about all aspects of the homosexual "lifestyle" and sex changes.

- Newton police remove two parents from high school assembly where speakers are telling kids how to "come out" as homosexuals, after a mother starts videotaping. School says it's for the students' "safety" that these sessions must be kept confidential. The next day, city permanently bans all parents from attending school programs on homosexuality for kids.

- Children's' picture books and classroom discussion promoting homosexual marriage, in elementary grades starting in Kindergarten.

- Schools across Massachusetts set up "safe zones" for so-called "gay / lesbian / bisexual / transgender / questioning" kids where they can go to be counseled by gay staff members without outside interference.

- School psychologists and counselors promoting homosexuality to our children in private, confidential meetings, with parents hearing only if the child shares this information.

- Youth surveys given by school asking 11-year-old girls about oral sex.

- 2nd-grade "health" education scaring little children about AIDS and talking about sexual body fluids.

- Graphic "Little Black Book" on explicit and dangerous male homosexual sex practices distributed to middle and high school students at homosexual "conference" for kids & teachers at Brookline High School, April 30, 2005.

- "Day of Silence" (actually Day of Homosexual Propaganda) to give children a sense of solidarity with homosexual movement, held in high schools and middle schools across Massachusetts during April.

- Cross-dressing day planned at a Massachusetts middle school by school officials to coincide with "Day of Silence" at local high school (cancelled at last minute when parents found out).

- Academic lesson plans (in science, math, English, social studies) incorporating subtle and not-so-subtle gay/lesbian/transgender propaganda.

- More and more school "gay/straight alliance" clubs (promoted by national homosexual groups and the Governor's Commission on Gay & Lesbian Youth) recruiting our children into this dangerous "lifestyle".

David Parker was the man who finally stood up and said "Enough!" He put himself and his family on the line and got arrested and put in jail. We need to support him by standing up ourselves and taking back our government!

The tools are in place for the people to take back their government, in this time of crisis. But it's up to you to get involved, take the initiative, and make it happen.

The Bill of Address:

This is the instrument put into the Massachusetts Constitution by John Adams in 1780 specifically to deal with judicial activism – judges who get out of control and put ideology before proper interpretation of law. Is different from "impeachment." The Bill of Address is part of the "checks and balances" to keep government honest, and is meant to be used when necessary.

It requires a simple majority of the House and Senate, plus the agreement of the Governor and the governor's council. It's been used successfully several times in the state's history. Most recently, Judge Maria Lopez resigned two weeks **after** a Bill of Address was presented against her.

The **Bill of Address** is currently before the Judiciary Committee - **Bill # H652**.

Resolved, That both houses of the legislature hereby request the governor by way of address, under the provisions of Article I Chapter III of Part the Second of the Constitution, to remove Margaret H. Marshall, Chief Justice of the Supreme Judicial Court, from her office, to remove Roderick L. Ireland, Associate Justice of the Supreme Judicial Court, from his office, to remove John M. Greaney, Associate Justice of the Supreme Judicial Court, from his office, and to remove Judith A. Cowin, Associate Justice of the Supreme Judicial Court, from her office.

These are other bills before the Legislature introduced by Article 8 Alliance, to take back our government (Status - in Judiciary Committee):

Bill # 653. AN ACT TO DEFINE MARRIAGE AS THE UNION OF ONE MAN AND ONE WOMAN

[Officially, in statute, reiterates marriage as one man and one woman. Actually, the ruling didn't change any existing laws.]

Sponsor: Rep. Emile Goguen. Co-sponsor: Rep. Philip Travis.

Bill # H654. AN ACT TO CLARIFY THE STATUS OF SAME-SEX MARRIAGES PERFORMED UNDER PUBLIC AUTHORITY IN MASSACHUSETTS SINCE MAY 17, 2004.

[Nullifies all same-sex "marriages" performed in Massachusetts.]

Sponsor: Rep. Emile Goguen.

Bill # H1050. UPDATED PARENTAL NOTIFICATION LAW – AN ACT RELATIVE TO PARENTAL NOTIFICATION AND CONSENT.

[Strengthens the current notification law, to (1) specifically include "sexual orientation issues", (2) make all such activities "opt-in" and non-mandatory, like other electives in schools; and (3) not require teachers to participate if it violates their religious beliefs.]

Sponsor: Rep. Joyce Spiliotis. Co-sponsors: Sen. Robert Hedlund, Sen. Richard Moore, Rep. Bruce Ayers, Rep. Vinny deMacedo, Rep. Emile Goguen, Rep. Shirley Gomes, Rep. Robert Hargraves, Rep. Paul Kujawski, Rep. James Miceli, Rep. Shirley Owens-Hicks, Rep. Marie Parente, Rep. Jeffrey Perry, Rep. Philip Travis, Rep. Daniel Webster.

Status: Before Education Committee. We're told this will be acted on this fall.

What about a Constitutional Amendment?

Another Constitutional Amendment WON'T WORK. It's a Trojan horse that's failed twice already. The Massachusetts Constitution is not the problem. The problem is that we've lost control of our government. Unless we solve **that** problem, **any constitutional amendment is ultimately worthless**. For if the Constitution can be violated and re-intrepted at will, what good is another amendment? If we don't recognize this we are just opening ourselves up to more horrors and catastrophes down the road.

The people say: The marriage laws in Massachusetts were never legally altered. If the homosexual lobby wants a state-wide vote, let THEM draft a constitutional amendment and get signatures.

What you can do!

The challenges before us are not insurmountable. But it's going to take everyone's help. We can and will succeed! Try to think of one thing you can do every day. . .

- **Don't be afraid. Be willing to tell the truth.** Don't be intimidated by name calling, hostility, twisted logic, and other psychological devices the homosexual movement (and the media) use to silence you.

- **Call (or better, visit) members of the Judiciary Committee (see following page) and demand that the Bill of Address be passed on to the full Legislature.**

RIGHT NOW: Call the House and Senate Chairmen of the Judiciary Committee!!!

(Information on the new Parents' Rights bill, public hearing, etc., listed on opposite page, will be available as soon as we know more.)

- **Call the Governor's office, 617-725-4005, and demand that (1) he support the Bill of Address to give us back a free government; (2) his administration NOT support the homosexual agenda in the schools through his Department of Education, and (3) he eliminate the odious Governor's Commission on Gay and Lesbian Youth.**
- **Call (or better, visit) your own State Representative and State Senator and demand their support for the Bill of Address. State House switchboard: 617-722-2000.**
- **Better yet, organize a group in your district to meet with your State Representative or State Senator.**

Bringing more like-minded people on board, raising money, and getting the word out are all important. You can . . .

- **Get signatures in your community** for the petition to support David Parker and the Bill of Address, to be presented to the Governor and Legislature. (Can be downloaded from website, or available from us.)
- **Form a local Article 8 chapter in your community. We can help you do that.**
- **Write letters to the editor, call talk radio shows -- let the truth out!**
- **Organize a local rally** in your area to support David Parker, the Bill of Address, and the right of the people to have a free government. **Or a forum in your church** to inform people (we will supply speakers).
- **Organize a standoff / demonstration** in your town, over a highway, etc. It's a great way to show the public that there is a serious opposition movement!

Confronting the Judiciary Committee and State Legislature

Your right and duty as a citizen.

The right and duty of citizens to confront their elected officials and make their views -- and demands -- known to them is as old as America. It's enshrined in the US Constitution, for our founders knew that a major principle of a successful democracy is that the rulers are the servants of the people -- not the other way around. But sadly, it's been the special interests that engage the time and energy to confront our Legislature, not us. And we're paying for it now.

The Bill of Address is before the Judiciary Committee of the Massachusetts Legislature. There was a public hearing this past April. Any week now this committee will be voting whether to either (1) put it in a "study" (which means "killing it") or (2) move it forward to the full Legislature. They're under pressure from the homosexual lobby, and from the liberal leadership, to kill it. The legislators don't want this kind of aggravation. We say: that's too bad. We demand it.

Call them. Don't be afraid to call them at home. Meet with them. Bring other people. Let them know that this is not negotiable. We want control of our government back.

Tell them:

1. You must support the Bill of Address, H652, **and move it out of committee to the full Legislature to vote on.**
