AFFIDAVIT OF LISA MILLER IN SUPPORT OF SUPPLEMENTAL MOTION TO MODIFY OR ANNUL VISITATION ORDER

- I, Lisa Miller, am over the age of 18 and otherwise competent to testify regarding the matters set forth in this affidavit and make the following statements based upon my own personal knowledge:
- Pursuant to the current order governing visitation, during the weekend of November 3-4, 2007, I drove IMJ to the home of Janet Jenkins' parents in Berryville, Virginia for a visit with Janet.
- 2. Upon picking up IMJ on Sunday, November 4, I and others have observed extremely disturbing behaviors by IMJ. I have personally observed the following:
 - She pushed a comb against her stomach and threaten to kill herself:
 - She has openly and excessively masturbated;
 - She tried to force a pen into her vagina;
 - She refuses to be herself, but instead insists that she is a baby animal, requiring that I do everything for her;
 - She has started sucking her thumb (something she has never done before);
 - She has drawn disturbing pictures such as houses without any windows and doors, people in the woods she is afraid of, and has reverted to drawing pictures that are scribbles;

- She has been crying at night, begging me not to make her miss school, not to make her spend the night with Janet, and to promise that she does not have to take a bath or a shower while with Janet;
- She prays at night that God would not to let her "mommy change:"
- She has hidden under the table and refused to come out when I try to talk about the upcoming visit;
- Over the past two days she has started masturbating again, after having stopped for a period of time;
- Over the past two days she has told me she is going to hurt me and "knock me in the head" if I "say Janet's name";
- She is scared, out of sorts, and upset by Janet's refusal to speak to me, even when all three of us are present at the same place;
- 3. The incident in which IMJ threatened to kill herself occurred just after she commented about having to go to a new school in Vermont (apparently prompted by a conversation she had had with Janet).
- IMJ has revealed more about what bothers her over time; she is slow to talk about 4. what has happened to her, and still refuses to discuss certain things. She simply gets quiet and does not answer questions when the topic concerns something she does not want to talk about. During the last two days she has started hiding when I try to talk about the upcoming visit. She has also told me she is going to hurt me if I say Janet's name. She has also come up to me and hit my mouth and told me she is taking a key to lock my mouth and she is going to throw it away. She then runs and hides.
- 5. For the last visit with Janet, IMJ and I baked sugar cookies for her. But when IMJ came home, she was hurt to find the entire bag of cookies crushed underneath two pumpkins Janet had given her. Janet did not thank IMJ for the cookies, either.
- 6. Janet has repeatedly made comments to the effect that custody of IMJ will soon be transferred to her. For example, at drop off on Saturday, November 3, 2007, while IMJ was jumping up on me, Janet said with respect to IMJ's Christmas plays (for which Janet would not

let IMJ attend practices while she was visiting Janet) that IMJ "will probably be with her" by the time the plays are performed anyway, so there was no need to worry about IMJ's going to practices.

- 7. On her first day back with me, Sunday, November 4, 2007, all day at church she did not want to be near me, and then she refused to be herself, instead pretending to be a baby bunny. This went on until late afternoon, when she finally fell asleep. When she awoke, she told me she IMJ again, but all she could do was cry for the longest time. She continues to lapse in and out of being baby animals where one time she was a baby tiger and proceeded to bit and scratch me.
- 8. On or about Friday, November 16, 2007, I was contacted by Child Protective Services (CPS) concerning a report of alleged child abuse involving IMJ. The allegations center around the events of November 3-4, 2007. The investigation is ongoing, and will involve interviews of several witnesses as well as both parties to this litigation, and a physical examination of IMJ.
