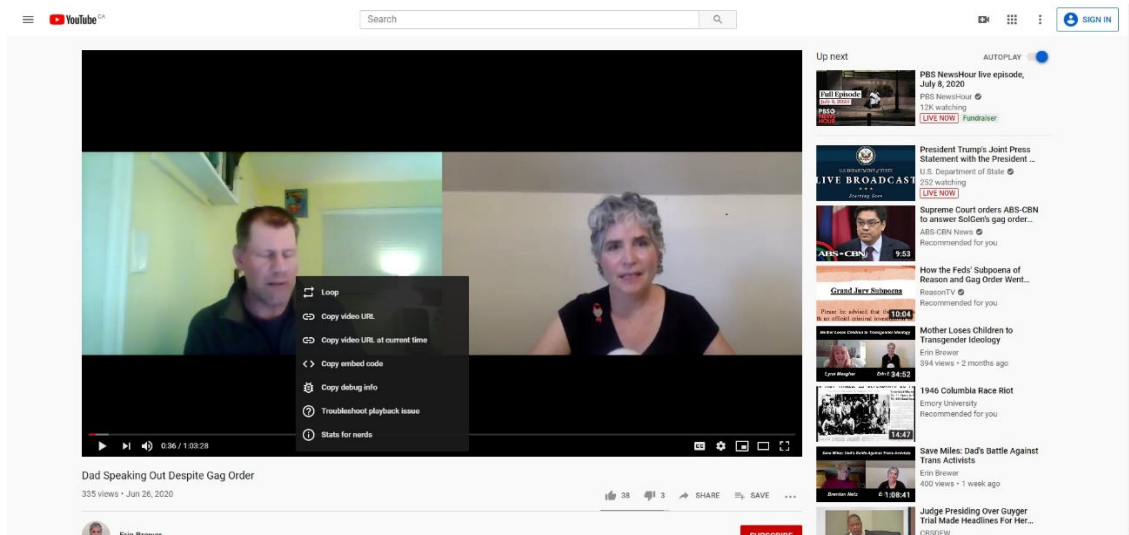


2- captured 2020/07/08 1525 hrs

- On July 8, 2020 Pyper contacted Crown and advised that the video had been downloaded

- On July 9, 2020 Pyper added to the a/m Hunchly capture to include the comments section of the Youtube web-page
- On July 21, 2020 Pyper subsequently received additional request for assistance from Crown
- On July 21, 2020 Pyper hand delivered 2 copies of a DVD with video burned onto it (per request Crown Pruim) to Crown office 5<sup>th</sup> floor 865 Hornby St attention at 1300 hours

July 22, 2020 – 1530 hrs

- On July 22, 2020 Pyper requested transcription of aforementioned video from transcription services
- On July 22, 2020, again using Hunchly (Citrix session on VPD box), Pyper captured several sites on the web (per URL's from Pruim). Pyper downloaded a video from <https://gogetfunding.com/bc-father-fighting-medical-transitioning-of-children/>. (interview between CD and 'Frank Vaughn').
- Pyper noted the name of the video as 'INTERVIEW - The Father Who Cannot Speak His Own Name-9vt6hjo3vYA.mp4' (name derived from URL by downloading tool). Pyper noted that the video was 43 min and 39 sec in length and 418,769 KB in size (right-click 'Properties').

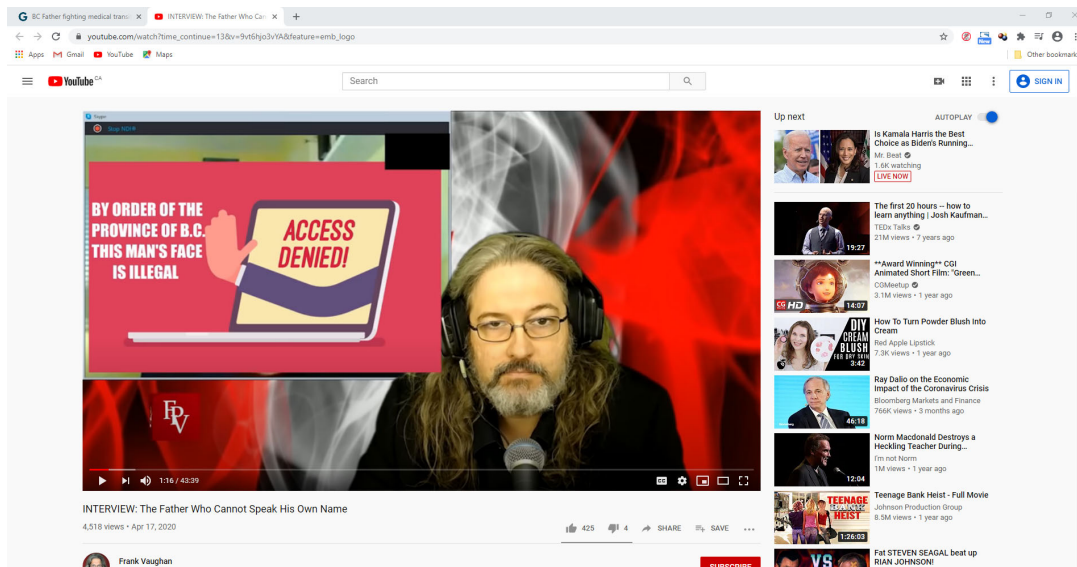

- On July 22, 2020, Pyper also hashed the video that was downloaded on July 8<sup>th</sup>. (Hash E9EE5D5CC6B543A46F8624F5F2A6266BF7F65BA61170C01B8AEDAAB3FCC56496 SHA 256)
- On July 22, 2020 Pyper sent a request to video transcription to transcribe the content of the video downloaded from Youtube on July 8<sup>th</sup> 2020 (Dad Speaking Out Despite Gag Order-0a1qUsk3reY.mp4)

August 12<sup>th</sup> 2020 – 1515 hours

- On July 29, 2020 Pyper received transcription result from transcription services, reviewed and passed on to Crown on July 30, 2020.
- On August 11, 2020 Pyper reviewed previous video evidence collected and noted the view count for Dad Speaking Out Despite Gag Order-0a1qUsk3reY.mp4 (at 335 views at the time of the video download). Pyper noted that this information was not captured for the video INTERVIEW - The Father Who Cannot Speak His Own Name when it was download on July 22<sup>nd</sup> (not displayed on the webpage <https://gogetfunding.com/bc-father-fighting-medical-transitioning-of-children/>). Pyper visited the underlying Youtube video imbedded in this web-page and noted there were 4,318 views of this video at that time.

**AFFIDAVIT OF KATHLEEN WORKMAN**

I, Kathleen Workman, Paralegal, of 500 - 865 Hornby Street, Vancouver, British Columbia,  
AFFIRM THAT:

1. I am employed as a paralegal with the BC Prosecution Service, solicitor for the intervenor, Attorney General of British Columbia and, as such, I have personal knowledge of the matters hereinafter deposed to. One part of my duties is to review and provide disclosure of the Crown's evidence to the alleged contemnor in the contempt proceedings herein.
2. On February 23, 2021, I received an email from Daniel Pruim, Crown counsel, containing a link to a GoGetFunding page: <https://gogetfunding.com/bc-father-fighting-medical-transitioning-of-children/>
3. I accessed the link and was directed to the website GoGetFunding. The title of the campaign was, "BC Father fighting medical transitioning of 14 year old child". Immediately beneath the title it stated that the fundraising campaign was by C.D., however it stated

C.D.'s full name. Attached and marked **Exhibit "A"** to this my Affidavit are two screen captures of the main GoGetFunding page taken on March 1, 2021.

4. When I clicked on C.D.'s name from the main fundraising page, I was taken to a page that stated that C.D. "joined on Feb 16, 2020". Attached and marked as **Exhibit "B"** to this my Affidavit is a copy of a screen capture from that page, taken on March 1, 2021.

5. On March 1, 2021, the page had 207 backers who had donated a total of \$12,538 CND; and, 82 people following the campaign.

6. On February 23, 2021 and again on March 1, 2021 I viewed the video posted under the "Story" tab on the GoGetFunding page. Attached and marked as **Exhibit "C"** to this my Affidavit is a USB containing a copy of that video. This video is also located at <https://vimeo.com/446235695>.

7. At the 53 second mark of the video a title appears reading "CANADA FATHER LOSES PARENTAL RIGHTS" followed by a clip of C.D. attributed to "Laura-Lynn's Live Show". C.D. appears on screen with his full name visible. C.D. immediately refers to his "daughter". At the 1:01 mark of the video a picture appears on screen of C.D. and A.B. C.D. again refers to A.B. as his daughter and uses female pronouns, while explaining that he has been ordered not to use female pronouns when referring to A.B.

8. The video then shows clips of unrelated individuals. At the 10:42 mark of the video a title appears on the screen that reads, "ROB'S STORY CONTINUES". C.D. is again shown on screen, the narrator uses his full name. The video is attributed to "The Federalist". The narrator refers to A.B. as C.D.'s "now 15 year-old daughter". At 10:53 court documents begin to be shown on screen. At 11:48 C.D. begins speaking, the clips are attributed to "Laura-Lynn's Live Show". C.D.'s name appears in full on screen and he refers to A.B. as his "daughter" and uses female pronouns numerous times. At 11:48 C.D. talks about how things changed for A.B. in grade seven, and goes on to say that A.B. changed his female name to a male name. At 12:14 a photograph of A.B. appears on screen.

9. At the 12:26 mark of the video C.D. refers to I.J. by name. A photograph of I.J. is then shown on screen. At 12:31 C.D. talks about the assessment I.J. provided about A.B. and states that I.J. advised C.D. that "your daughter is a boy but a gay boy". C.D. goes on to say that "apparently they were going to start pumping her full of testosterone and cross-sex hormones and Lupron..." At 12:40 C.D. discusses the risks to A.B. that were detailed in a form he was provided.



10. At the 13:14 mark of the video C.D. is shown on screen holding a picture of A.B. At the 13:17 mark another photograph of A.B. is shown, this time with a birthday cake. On the cake A.B.'s name at birth is clearly visible. At 13:23 and 13:28 of the video additional photographs of A.B. are shown on screen. At 13:34 C.D. states that, "I wasn't able to prevent my daughter from receiving cross-sex hormones and her life is irreversibly changed forever."

11. The video then goes on to discuss other individuals. At the 16:11 mark of the video C.D. again appears on screen, his full name visible. He immediately begins to refer to A.B. using female pronouns. At 16:20 C.D. states that "she's gonna forever have a lower voice, she'll forever have to shave cause of facial hair, she won't be able to have children, she won't have a family..."

12. At 16:16, 16:20, 16:26, 16:31, 16:35, 16:40, 16:43 and 16:53 photographs of A.B. are shown. In total thirteen different photographs of A.B. are shown throughout the video.

13. I have reviewed the various court orders relating to these proceedings which include the following conditions contained within the Order Made After Application of this Court, issued by the Honourable Mr. Justice Tammen on February 21, 2020, which is attached and marked as **Exhibit "D"** to this my Affidavit:

Para. 1 Paragraph 6 of the order of Mr. Justice Bowden dated February 27, 2019, is replaced with the following:

The publication, broadcast or transmission of any information that could disclose the identities of A.B., his father, or his mother, is prohibited. For greater clarity, broadcast or transmission includes re-broadcast, re-transmission, or republishing on any paper, digital, electronic, or other means of publication. For further clarity, broadcast includes the second definition in the Oxford Concise Dictionary: "make known to many people."

Para. 3 Laura Lynn Tyler Thompson, Jenn Smith and C.D. must monitor their social media platforms, including but not limited to Facebook, Twitter, Bitchute and YouTube, and remove any comments made by third parties on those social media platforms which provide links to material or which comments themselves contain information that:

(a) Could identify the parties referred to in these proceedings as A.B., C.D., and E.F., or

Para. 5 The term of the orders made by Mr. Justice Tammén on February 12<sup>th</sup>, 2020, which reads:

Includes prohibiting C.D. and Jenn Smith from repeating or otherwise making such information known in any forum, including in writing, orally, by any electronic medium, by telephone, or in person, in relation to these proceedings.

14. Attached and marked as **Exhibit "E"** to this my Affidavit is the Order Made After Application of this Court, issued by the Honourable Madam Justice Marzari on April 15, 2019. This Order specifies how the individuals involved in these proceedings are to be identified, including A.B., C.D. and I.J.

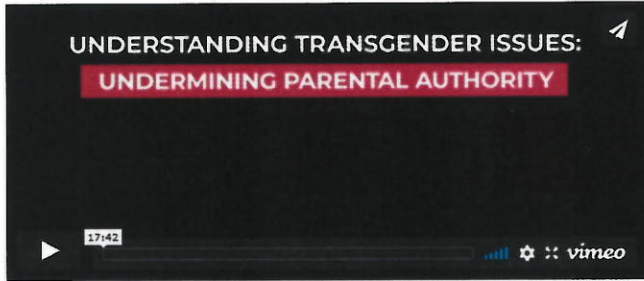

### ORDER MADE AFTER APPLICATION

} FRIDAY, THE 21<sup>st</sup> DAY  
OF FEBRUARY, 2020

ON THE APPLICATION of the Claimant A.B., filed February 18, 2020, coming on for hearing at 800 Smithe Street, Vancouver, BC on February 21, 2020 and on hearing: barbara findlay, QC, Claire Hunter, QC, and Sarah Chaster, counsel for the Claimant, A.B.; Dionne Liu, counsel for G.H., Stephanie Hamilton, counsel for I.J. and PHSA; Jessica Lithwick, counsel for E.F.; Robert Danay, counsel for the Attorney General of British Columbia; Carey Linde, counsel for C.D.; Jenn Smith appearing on his own behalf; and Laura Lynn Tyler Thompson appearing on her own behalf.

THIS COURT ORDERS AND DECLARES that:

1. Paragraph 6 of the order of Mr. Justice Bowden dated February 27, 2019, is replaced with the following:

The publication, broadcast or transmission of any information that could disclose the identities of A.B., his father, or his mother, is prohibited. For greater clarity, broadcast or transmission includes re-broadcast, re-transmission, or republishing on any paper, digital, electronic, or other means of publication. For further clarity, broadcast includes the second definition in the Oxford Concise Dictionary: "make known to many people."

2. The term "remove" in the order made by Mr. Justice Tammen on February 12<sup>th</sup>, 2020, which reads:

"Laura Lynn Tyler Thompson must remove forthwith the February 9, 2020 video interview of C.D and reference to the names of the parties to this proceeding, and the medical professionals in A.B.'s care, from any platform where she has posted the video, including but not limited to Facebook, Twitter, BitChute, Youtube,"

includes removal from any platform, regardless of whether the video has already been made unavailable by the platform on which the video found, and regardless of any privacy settings on the video, including whether those settings have been made private or left public. For avoidance of doubt, the requirement that the video be removed includes taking all steps to delete all files or information in relation to the video from accounts controlled by Ms. Thompson on any platform.

3. Laura Lynn Tyler Thompson, Jenn Smith and C.D. must monitor their social media platforms, including but not limited to Facebook, Twitter, Bitchute and YouTube, and remove any comments made by third parties on those social media platforms which provide links to material or which comments themselves contain information that:

- (a) could identify the parties referred to in these proceedings as A.B., C.D., and E.F., or
- (b) includes the use of non-anonymized names or contact information of the Health Care Providers as defined in the April 15, 2019 order of Madam Justice Marzari in relation to these proceedings or any proceedings regarding A.B.'s care or counselling.

4. Laura Lynn Tyler Thompson, Jenn Smith and C.D. are restrained from encouraging or directing any person publicly or privately to take any step which may lead to a breach of the orders of this court in this proceeding.

5. The term of the order made by Mr. Justice Tammen on February 12<sup>th</sup>, 2020, which reads:

"C.D. and Jenn Smith are prohibited from publishing information relating to A.B.'s gender identity, physical and mental health, medical status or treatments and information that could identify the names of the parties referred to in this proceedings as A.B., C.D., E.F., G.H., I.J., K.L., M.N., O.P., Q.R., S.T., U.V., and W.X.,"

includes prohibiting C.D. and Jenn Smith from repeating or otherwise making such information known in any forum, including in writing, orally, by any electronic medium, by telephone, or in person, in relation to these proceedings.

6. C.D. is required, pursuant to section 228 of the *Family Law Act*, forthwith to make best efforts to remove any posts of any interviews he has given in breach of orders of the court, including contacting all persons to whom he has provided interviews to advise them that the interviews were provided in breach of orders of the court and advising them that the continued publication of such interviews is in breach of court orders, and requesting that the interviews be removed and advising them that he withdraws any consent he has previously provided for the use of his name, his image, and/or any image



of A.B. and to provide copies of that correspondence to counsel for A.B. by noon on Monday, February 24, 2020.

7. C.D. is restrained from posting online, on Facebook, GoGetFunding, or any other online forum, in a manner that may identify him as the father in these proceedings.
8. By consent, applications for the enforcement of court orders issued in this proceeding can be served by email on: Jenn Smith, Laura Lynn Tyler Thompson, and on C.D. through Carey Linde.
9. A direction that March 9, 2020 be reserved for a full-day hearing in front of Mr. Justice Tammen for the parties to this application to reappear to address any applications or request for directions in relation to the publication bans and conduct orders in these proceedings.
10. Costs by ~~each of the application respondents~~ <sup>C.D.</sup> to A.B. in a lump sum amount of \$500 payable forthwith.

AND JUDGMENT BEING RESERVED TO THIS DATE:

THIS COURT ORDERS that:

1. The term of the order of Justice Bowden of February 27, 2019 that "the applications of PHSA and Dr. Brenden Hursh are dismissed" is hereby set aside.
2. In these proceedings and in any pleadings and reasons for judgment:
  - (a) Brenden Hursh be identified by the pseudonym "G.H.";
  - (b) Wallace Wong be identified by the pseudonym "I.J.";
  - (c) Daniel Metzger be identified by the pseudonym "D.M.";
  - (d) Andrea Chapman be identified by the pseudonym "A.C.";
  - (e) Shazhan Amed be identified by the pseudonym "S.A.";
  - (f) Pam Narang be identified by the pseudonym "P.N.";
  - (g) Alice Virani be identified by the pseudonym "A.V.";
  - (h) Robyn (Roberta) Lalani be identified by the pseudonym "R.L."; and
  - (i) Janice Vanderspek be identified by the pseudonym "J.V.",  
collectively, the "Health Care Providers"
3. The style of proceeding in petition S-191565 shall be amended:
  - (a) to identify Brendan Hursh by the pseudonym "G.H",
  - (b) to identify Wallace Wong by the pseudonym "I.J.",
  - (c) to reflect the discontinuance against A.B.'s elementary and high school counsellors, and
  - (d) to reflect the addition of A.B. as a respondent;

4. There shall be no publication in any document, broadcast or transmission of the use of the names of the Health Care Providers, not anonymized in accordance with this order, in connection with these proceedings and any related proceedings regarding A.B.'s care and counselling;
5. There shall be no publication in any document, broadcast or transmission of the Health Care Providers' contact information in relation to these proceedings and in relation to A.B.'s care generally;
6. There shall be a prohibition against the publication in any document, broadcast, transmission or dissemination, of copies, hyperlinks or descriptions of previous publications containing non-anonymized party and witness names, including any links or copies of prior versions of Mr. Justice Bowden's reasons for judgement herein;
7. The application of Dr. Brenden Hursh for a publication ban in relation to all facts and details that could lead to the identification by name of Dr. Brenden Hursh in relation to these proceedings is dismissed as abandoned;
8. The application of PHSA and Dr. Wallace Wong for a publication ban in relation to all facts and details that could lead to the identification by name of Dr. Wallace Wong, Dr. Daniel Metzger, Dr. Andrea Chapman, Dr. Shazhan Amed, Dr. Pam Narang, Alice Virani, Robyn (Roberta) Lalani, Janice Vanderspek and/or any other PHSA employees who are members of A.B.'s health care team in relation to these proceedings is dismissed as abandoned;
9. The petitioner in S-191565 shall re-file that proceeding in the Supreme Court Family Registry, complying with all other orders of this court regarding the proper parties and anonymization of names;

10. Any new filings, as well as the ordered refiling of this proceeding in the Family Registry, shall comply with this order and all previous orders; and


