


Puberty Blockers and Cross Sex Hormones for Minors

There has been a 4000% increase in female gender dysphoria referrals in the last decade, especially among pre-teens and teens.




But why are three-year-olds claiming they are the "wrong gender"?

Notice how many of these books are about a boy who feels he is really a girl.




These are just a few of hundreds of books available to young children.

EARLY CHILDHOOD EXPERIENCE

Most children between the ages of two and four years correctly identify their own biological sex.

Most children between the ages of four and five years begin to understand sex is stable - a boy grows into man and a girl to a woman.

WHY ARE THERE 3-5 YR OLD TRANS?

WHAT HAPPENS WHEN A CHILD CLAIMS TO BE TRANSGENDER?

- \rightarrow Social Affirmation Praise Hero Status and Acceptance
- ightarrow Puberty blockers are often administered in Tanner Stage II

WHAT'S TANNER STAGE II? WHY THEN?

Before the first visible sign of sexual maturation. For girls, puberty ranges from 8 to 13. For boys, from 9 to 14.



Neuropsychological Effects of Puberty Blockers

Emotional lability, mood changes, headaches, insomnia

Results from study at Tavistock gender clinic (UK)

No statistically significant difference in psychosocial functioning Children reported greater self harm.

Girls exhibited more behavioral and emotional problems, greater dissatisfaction with body

WHAT ARE THE PHYSICAL EFFECTS OF PUBERTY BLOCKERS

Arrest normal sexual maturation

Bone length - bone density (height – early osteoporosis) Development of secondary sex characteristics (infertility) Sexual organization of the brain (cognition, memory, execution function)

Pre-dispose to disease states

Cardiovascular (hypertension, stroke, blood clots, heart attack) Cancers (breast, ovarian, testicular and more) Diabetes and other hormonal imbalances; osteoporosis Premature menopause and andropause

WHAT HAPPENS NEXT?



Almost 100% of kids taking PBs go on to use cross-sex hormones

A study has shown all but one child treated for gender dysphoria with puberty-blocking drugs at a leading NHS clinic - The Tavistock and Portman Trust - also received crosssex hormones.



Tavistock puberty blocker study published after nine years

IN THE SHORT TERM, CROSS-SEX HORMONES GIVE KIDS WHAT THEY WANT-


A girl looks (beard, body hair) and sounds (lower voice) more masculine. A boy looks (no beard, smaller bones) and sounds (voice) more feminine.

Normal (blue) healthy female testosterone level - 15 to 70

Unhealthy levels of testosterone

Polycystic ovarian syndrome -PCOS disorder

Endocrine tumor – disease state

Female to male "transitioning" testosterone levels are 5 to 20 times higher than the female body is regulated for.

Male testosterone range 300-1200

Results of taking Puberty Blockers and Cross-sex Hormones

Arrest normal sexual maturation—

Bones, sexual organs, secondary sex characteristics, sexual organization of the brain including memory, cognition, and executive function


Pre-dispose to disease states-

Cardiovascular effects (hypertension, stroke, blood clots, heart attack), cancers, diabetes, osteoporosis, premature menopause and andropause

Surgical mutilation-

Removal of healthy organs such as mastectomy, hysterectomy, oophorectomy, orchiorectomy (castration), penectomy

Dr. David Bell was a consulting psychiatrist at Tavistock for 24 years. Bell recently said using an affirmation approach instead of neutrality had caused serious damage to gender confused children, who were inappropriately pushed through transition while their complex psychological problems were not investigated.

Bell added that puberty blockers have no evidence base for use.

Swedish psychiatrist Christopher Gillberg testified that the use of puberty blockers is basically "a live experiment" on children. He wrote, "We have left established evidencebased clinical practice and are using powerful life-altering medication for a vulnerable group of adolescents and children based on a belief."

U.S. states moving to protect vulnerable mínors → In a near-unanimous vote, the Alabama Senate passed a bill, called the "Vulnerable Child Compassion and Protection Act," to ban the medicalized gender-transitioning of minors, outlawing the prescribing of puberty blockers, cross-sex hormones, and performing genital mutilation and double mastectomies on youth younger than 19.

The bill will soon head to the Alabama House, which has already passed a companion bill.
