850 RABBIS PLEAD WITH NJ GOVERNOR CHRISTIE:
DON'T ABANDON YOUR BIBLE-BELIEVING, PRO-FAMILY BASE –
UNCONDITIONALLY VETO THE “K-12 LGBT-ADVANCEMENT” BILL TODAY

In a last-ditch effort to solicit a **full, unconditional** gubernatorial veto of a bill that many experts consider “a pernicious hijacking of the bullying problem to promote the militant homosexualist agenda, and the **State-sponsored bullying** of defenseless, Bible-adherent school-children,” **Rabbi Yehuda Levin** issued the following statement:

“Speaking on behalf of our 70-year-old national Rabbinic organization, the **Rabbinical Alliance of America**, comprising over 850 Rabbis nationwide, scores of whom reside in NJ, we issue the following plea to the Governor of New Jersey, the Honorable Chris Christie:

“Many Bible-believing New Jersey voters, and many Orthodox Jews in particular, actively supported your gubernatorial candidacy last year. They supported you primarily because of your opposition to same-gender ‘marriage’ and abortion.

“We assume that you recognize the magnitude of the threat homosexual ‘marriage’ poses - to society as a whole, and to Bible adherents in particular. As legal scholars have observed, homosexual marriage legislation threatens to legally brand Bible adherents as bigots. This would, in turn, manifest in a multitude of legal ramifications, including influencing what our children would be force-fed in public schools.

“We supported your candidacy despite your decision to not to seek the abolishment of Civil Unions, being spiritually akin to homosexual marriage, and just a few steps removed legally.

“Gov. Christie, the militant homosexualist social engineers are never, ever satisfied. They are incessantly pushing the envelope. **If you merely provide them with a conditional veto, they will have won all of the territory you ceded – and they will be continuously agitating for more.** They will do so - for long after you will have left Trenton – to achieve additional elements of the LGBT agenda that are even more deleterious.

“For recent evidence of the ongoing nature of radical LGBT advancement, note, for example, the homosexualization of the military (which is precisely what it is, all media-genic pseudonyms notwithstanding), and Obama’s intensification of the assault on Marriage.

“This bill, written by LGBT radicals, is not truly about protecting children from bullying or anything else. It’s about advancing the LGBT agenda in schools – K-12.

“A disillusioned nation seeks genuine values-based, pro-family leadership. We beg you to demonstrate the same conviction and values you’ve shown in the recent past. We know that you can stand up to powerful special interests, when the hour demands it.

“Mr. Governor, there can be no compromise on the moral **survival** of New Jersey’s children. We urge you: **veto A3466/ S2392 in full, unconditionally.** The Almighty, and the nation, is watching.”
